Objectives and Investment Policy

Investment Objective:

To provide investors with medium term capital growth by investing predominantly in Eurozone fixed interest securities, all of which will be at least Investment Grade.

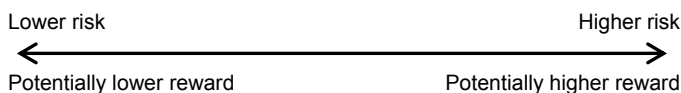
Investment Policy:

The Fund will invest in a portfolio of securities in Euro dominated short, medium and long dated fixed income securities of at least Investment Grade. Also the Fund may invest in fixed income securities of both government and non-government issuers in OECD Member States traded on permitted markets worldwide.

The Fund intends to invest predominantly in Euro denominated Eurozone sovereign bonds, short, medium and long dated fixed income securities, including bonds, notes and mortgage-backed securities of at least Investment Grade.

The Fund also may invest in non-sovereign fixed income securities denominated in multiple currencies, including bonds, notes (fixed rate notes and floating rate notes), convertible securities (including convertible bonds and convertible preferred stock), preferred stock and mortgage backed securities (and other asset backed securities) of corporate issuers.

Other Information:

- You can buy, exchange and sell shares in the Fund on a daily basis on any business day in Dublin.
- Subject to net income being available for distribution, the Directors intend to declare dividends on the distribution date, which shall usually be 31 March and 30 September in each year (the "Distribution Date") and such dividends will be paid on or before the 14th Business Day following the Distribution Date..
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

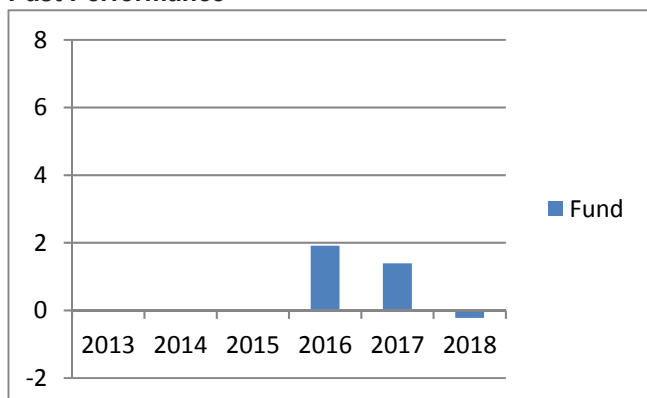
