Objectives and Investment Policy

Investment Objective:

To achieve capital appreciation over the long term.

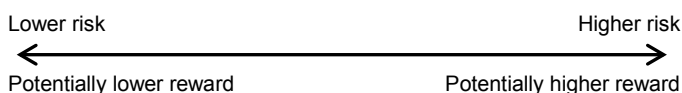
Investment Policy:

The Fund will invest primarily in a global portfolio of equity securities with diversification by sector and country. The Fund will invest in those markets as defined by the MSCI World Index (the "Index"). The Fund is not tracking the Index and will not invest in those assets used by the Index.

The Fund may not invest more than 20% of the net assets of the Fund in authorised open-ended UCITS with exposure to equities which will include, for the avoidance of doubt, Exchange Traded Funds ("ETF") and 10% of its net assets in alternative investment funds ("CIS").

The Fund may also hold Money Market Instruments for ancillary liquid purposes.

- This class does not intend to pay a dividend. Any income generated by the Fund is reinvested to grow the value of your investment.
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

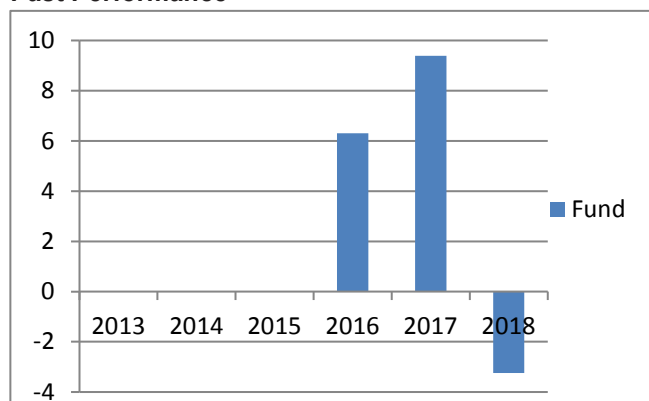
